S-200+S-202+S-201

Coverall with set-in sleeves, central closure with internal covering flap and external flap fixed by a hook-and-loop tape, oxygen tank-holder on the back, leg bottom with hook-and-loop tape closure. Coverall has a hood with visor and overboots with side opening closed with a flap fixed by a hook-and-loop tape.

Compound used for the manufacturing of the coverall, and of the overboots (except for the sole):

Aluminized fabric: pre-oxidized para-aramide 485 g/m² art. "AC 370 K"

Blue lining bonded with felt: 50% aramide and 50% viscose FR 525 g/m² art. "Firestop"

Fabric used for sole of overboots: 100% para-aramide internally bonded with fabric 100% viscose FR 645±5% g/m² yellow art. "A 379 K"

The present certificate has 5-year validity from the date of issue. On expiration date it will be responsibility of the Manufacturer to ask for the renewal.

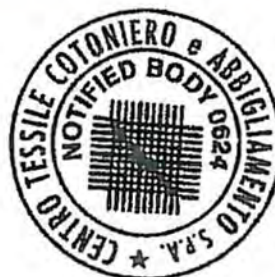
The applied standards are those in force on the date on the present Certificate. The validity of the certificate is not assured if revised standards are issued before its expiry date.
