Manufacturer's Technical Specification

The manufacturer's Technical Specification for clothing for the end use of protection from the thermal hazards of an electric arc was based on IEC 61482-2:2009 "Live working – Protective clothing against the thermal hazards of an electric arc – Part 2: Requirements". The materials and garment was assessed according to EN 61482-1-2:2007 "Live working – Protective clothing against the thermal hazards of an electric arc – Part 1-2: Test methods – Method 2: Determination of arc protection class of material by using a constrained and directed arc (box test)". The suitability of these standards was checked with respect to the Basic Health and Safety Requirements of EC Directive 89/686/EEC, and was found to address the requirements for this end use.

Limitations of Use

- Usage, maintenance and storage as per manufacturer's instructions.
- The garments were available in size ranges which did not conform to the requirements of EN 1149-5:2008, EN 343:2003, or EN 471:2003 which refer to EN 340, which in its latest version (2003) refers to EN 13402, nor did they conform to the requirements of EN ISO 11612:2008 and IEC 61482-2:2009, which refer to ISO 13688. In the opinion of BTTG Testing & Certification Ltd, these size ranges fulfil the requirements of Annex II, Clause 1.3.1 of Directive 89/686/EEC.
- The principal materials for the garment fully comply with the requirements of EN ISO 11612:2008 and IEC 61482-2. However one of the additional garment components will ignite (i.e. give an afterflame > 2 s) if a test flame is directly applied:
 - i) The small 'GORE-TEX' tag (present on Jacket) gave an afterflame of > 2 s.

The end user must decide on the basis of a risk assessment whether the use of this non flame retardant item is acceptable.
