Features patch cargo pockets with flap closures on the legs, a radio pocket and radio loop on the chest, front zip fastening with a hook and loop storm flap closure and collar with a hook and loop closure.

Suit comprising of Jacket reference W2220 and Trouser reference W2221 constructed from 99% Cotton / 1% Carbon fibre woven fabric (280g.m⁻²). The jacket features 78mm wide antistatic yellow-silver-yellow tape in two bands encircling the torso, with a single band encircling each arm. Features a single flapped chest pocket, front zip fastening with storm flap, hook and loop closure at the cuffs, storm flap neck and epaulettes. The trouser features features 78mm wide antistatic yellow-silver-yellow tape in one band encircling each leg, with a draw cord at each hem.
