The garments are available in nine nominal sizes in red and grey. The garments may have an 'AVIA' Name Badge applied post production constructed with an FR Base fabric of 99% Cotton, 1% Carbon Fibre 350 g/m² with FR Polyester Embroidery thread. The Garment is an accessory garment for heat and flame protection and is intended to be worn with an ISO 11612 compliant garment with full length sleeves where protection from heat and flame is required in accordance with the manufacturer's instructions for use.

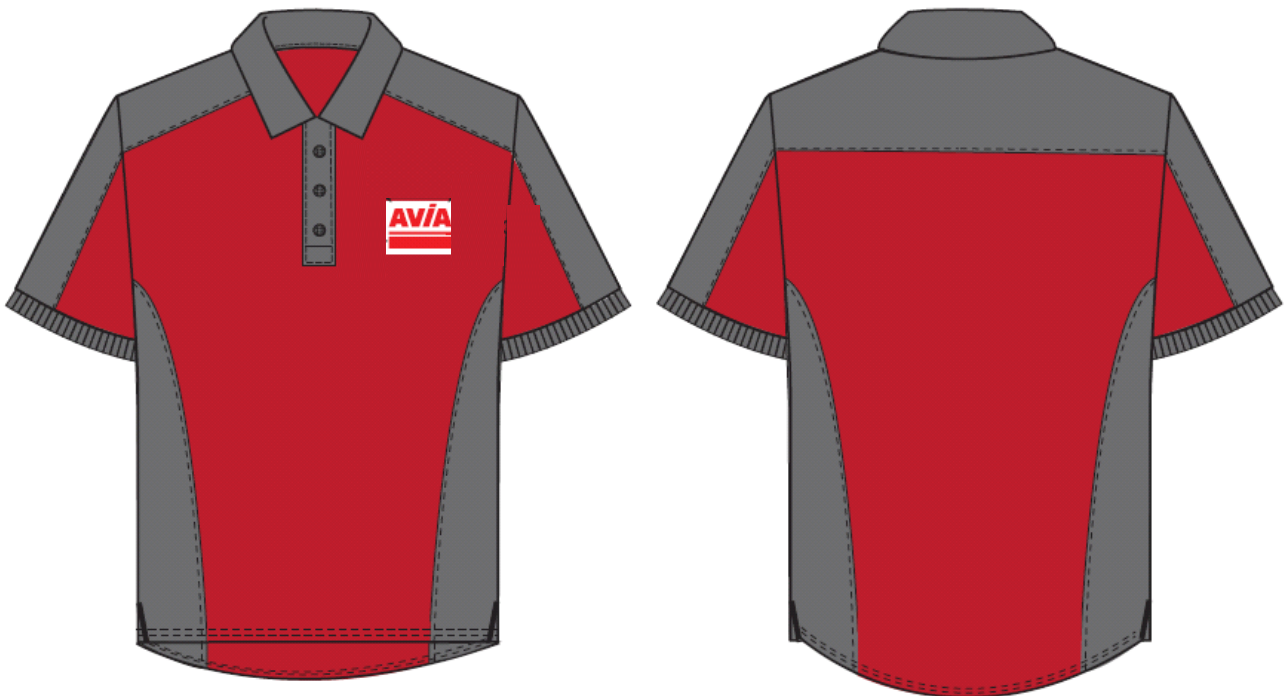
